CRUSHERS (Ages 6-8) 10 - 11:00am

Using a reduced size court and racquet with the **Orange** ball which bounces at 50% of the speed of a regular tennis ball, making it easier to hit, helping the children enjoy tennis and be happy with their progress.

CHAMPS (Ages 9-12) 11am -12:00pm

Players will learn how to serve, rally and play. Athletic development and basic strokes are emphasized in a fun, safe environment. **Green** ball bounces at 75% of the speed of a regular ball, which accelerates the learning rate.

CHALLENGERS TOUR (Ages 11+) 1 - 2:30pm

This is for developing players that have match play experience and wanting to improve their tennis skills. Emphasis is on stroke production, footwork, and match-play.

This class is for **teen players** with minimal or no match play experience. Emphasis is on basic stroke production, footwork skills, and match-play.
